E-Tenders are invited from *bonafide, resourceful, experienced and reputed firms* with required experience as per Prequalification criteria stipulated in the Tender Document for **"General Maintenance for Up keeping of camp premises, sheds/Building etc including Office room and providing services of a cook cum attended under Superintending Engineer(R.T.) at Phalta base Camp, Dist-24-Parganas(South) and Swarupgang Camp Office, Dist- Nadia for one year"**. as per the attached Bill of Quantities. Bid Document may be seen from CPP Portal. Corrigenda or clarifications, if any, shall be hosted on the above mentioned website only. The tender is also published on KoPT website (www.kolpkataporttrust.gov.in).

Tender documents will be issued to only those contractors satisfying the following eligibility criterion as mentioned below: -

"Tenderer should have experience in completing similar works during last 7 years ending at the last day of the month previous to the one in which applications are invited which should be either of the following: -

01. (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated value.
(b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.
(c) One similar completed works each costing not less than the amount equal to 80% of the estimated value.
Similar work means up keeping and general maintenance of buildings/sheds etc or similar works like deploying of labours at different works
02. (a) All intending tenderer at the time of tender shall disclose all necessary documents proof of registration with ESI

Tenderers are required to furnish relevant documentary evidence in the above regard. In case of any non-conformity to the same, the concerned tenders would be liable to be rejected".

- 3 (a) The successful tenderer will be required to comply with the relevant provisions of Building and other construction workers (Regulation of Employment and Conditions of Service) Act, 1996 and West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 2004 as well as Building and Other Construction Workers' Welfare Cess Act, 1996 and rules framed there under.
(b) An amount of cess calculated at the rate of 1% of the billed amount shall be progressively recovered from each running bill as well as from the final bill of the contractor for onward transmission of the same to the appropriate authority.
