The quotations shall have two parts viz. 'Techno-commercial Part' (Mock up Model /3D presentation to be submitted), and 'Price Bid' (to be submitted as per format in Annex – Price). Price Part should be submitted in sealed covers duly superscribed with "Price Bid for HDC Gate at Haldia Trade Fair, 2020" as the case may be in the office of Administration Division by 1300 hrs. on 20.01.2020.

The Techno-commercial Part' shall consist of:-

a) A mock-up model or 3D Presentation of HDC Gate at Haldia Trade Fair, 2020 reflecting the theme of 150 years of Kolkata Port Trust.

b) Details of design of the Gate including details, (size/dimension etc.).

The Price Bid shall consist of the 'Schedule of Rate' printed as Annex-Price. The Annex-Price shall be filled in and signed and then submitted in separate sealed cover as Price Bid.

The mock-up model or 3D Presentation will be evaluate at 1430 hrs on 20.01.2020 at the chamber of the undersigned. After evaluation of the mock-up model or 3D Presentation, the Tender Committee will select and interact with the bidding agencies on mock-up model or 3D Presentation submitted by them. The bidding agencies are requested to make themselves available for the above interaction with the Tender Committee on 20.01.2020. Price Bids of only those bidders will be opened whose mock-up model or 3D Presentation will be found to be

acceptable. Price Bids may also be opened on 20.01.2020 and the bidding agencies may be present during the said opening.

4.	The contractor has to maintain the electrical system in working order. During the period of exhibition, if any bulb, fitting, wire, switch, board etc., goes out of order, the contractor has to repair/replace and maintain the same immediately without any extra cost claim from Kolkata Port Trust, Haldia Dock Complex.		
5.	If any defect occurs during the period of exhibition, the contractor has to rectify it the same day by putting more men on the job without any extra claim.		
6.	The contractor is totally responsible for damage to men and material on account of any electrical fault or for any other reason. Hence he should take all precautions to avoid such faults.		
7.	All electrical wires and accessories used at site must be of high standard. If any defective material is noticed, contractor has to replace or repair the same immediately otherwise the same will be got done at once at his cost and risk without any notice keeping the emergency type of work in nature.		
8.	The contractor has to obtain Electrical and Water Connection from Haldia Municipality/Haldia Development Authority and to maintain the same for the duration of exhibition. Payment in this regard will be borne by the contractor.		
9.	Contractor shall be responsible for watch and ward of all type of materials and any loss due to damage/theft has to be made good by him at his own cost.		

TERMS & CONDITIOINS

- 1. Period of completion: The Gate must be ready in all respect at least one day before the inauguration of the exhibition i.e. shall be ready in all respect by 1000 hrs. on 30.01.2020. For non-completion of work within the specified time, the contractor shall be liable to pay compensation @ Rs. 20,000/- per day or part thereof.
- 2. KoPT may impose penalty for non-execution of ordered items.
- 3. Payment Terms:-

Payment will be made after satisfactory completion of the work, submission of final bill and deposition of all exhibits to HDC.

 The total financial offer shall be inclusive of GST as applicable and including cost of material, transportation of material to Haldia, cost of labour and all other allied costs.

- 3) Evaluation shall be on the basis of the lowest rate quoted among the total number of Mock up Model/3D presentation of the different tenderer selected by the officials of HDC under Item-A of the SCHEDULE OF RATES.

The lowest amount quoted under item-A of the SCHEDULE OF RATES against the Mock up Model/3D Presentation selected by the officials of HDC will become the successful contractor.


