Sr. Dy. Manager (P&E) Haldia Dock Complex, KoPT Collection of readings of electric energy meters, installed at various locations, under Haldia Dock Complex, Kolkata Port Trust, for 3 (Three) years' contract basis i.e. for 36 (Thirty Six) months.

### 1 SCOPE OF WORK

- 1.1 The contractor shall have to collect readings of electrical energy meters (2750 nos. approx.), under Haldia Township Zone / Residential Zone and under Chiranjibpur Power House/ Dock & Industrial Zone of Haldia Dock Complex, Kolkata Port Trust. Total quantity of energy meters in both the zones may vary ± 10%. However, payment will be made on actual quantity of reading of energy meters collected.
- **1.2** The contract shall be valid for three years from the date of actual commencement of work.
- 1.3 Rate for collection of each energy meter reading per month including all, will be as per quoted rate in the Price Bid. The rate includes collection of Meter reading and entry of data in meter reading book on monthly basis per consumer per meter.

- 1.7 The rate of collection of each energy meter reading & On line Data entry of energy meters readings collected shall be as per quoted & accepted rate which will be firm through out the contract period of three years.
- **1.8** All data entries shall be made before 7th day of each month.

#### 2 METHODOLOGY

- a) The certification of collection of energy meter readings will be done by the Sectional In-charge (Township Electrical Maintenance) for all the energy meters under jurisdiction of Township Electrical Maintenance / Residential Zone and the certification of collection of energy meter readings will be done by the Sectional Incharge (Chiranjibpur Power House) for all the energy meters under jurisdiction of Chiranjibpur Power House/Dock & Industrial Zone.
