1. **Objective**

Kolkata Dock System under Syama Prasad Mookerjee Port, Kolkata intends to bring bigger vessels, which are not able to call KDS due to low draft constraint. Sister vessel will be deployed by SMPK for transloading operations to overcome it.

2. **Broad Scope of Work**

- a) The regular feeder vessels coming to KDS can load Containers till Sandheads/NX/Sagar/Diamond Harbour Draft.
- b) The vessel deployed by the operator (henceforth referred to as sister vessel) shall discharge the boxes from the main feeder vessel by its own crane/ Floating Crane of Port (if available) till the main feeder vessel attains the Kolkata draft.
- c) Both the main feeder vessel and the sister vessel shall make inward to Kolkata Dock after the Transloading operations.
- d) The same operation may be carried out in the export leg too where the sister vessel deployed will be used to top up the main feeder vessel at the anchorages.

3. **Eligibility Criteria**

-

- a) The sister vessel deployed should be able to work in **KPD or NSD**.
- b) The sister vessel deployed should have **functional ship gears**
- c) Minimum Capacity of the vessel shall be **200 TEUs**
- d) **Minimum 10 years** of vessel/barge operation at KDS.

4. **Special Conditions**

- a) All Vessel & Cargo related charges or Royalty shall be as per extant practice and Scale of Rates.
- b) This service has to be run round the year.
- c) The Feeder operators are free to charge the desired slot /carriage rates directly from the Trade.
- d) Any change in this vessel is to be notified to port at least 14 days in advance.
- e) Port will not provide any Minimum Guarantee of container traffic.
- f) Validity of the facility will be **one year** from the date of issuance of offer letter.
- g) Port shall not be liable for Neaping/Bunching/Tide related factors.

5. **Award of Work**

The response from the Applicant, duly signed, should be submitted with the offer as token of acceptance of the terms and conditions of the Port. Port will issue the offer letter to the qualified applicant later.

6. **Final decision making authority**

SMPK reserves the right to accept or reject any application and to annul the process and reject all applications at any time without assigning any reason thereof and without thereby incurring any liability to the affected applicant or without informing the applicants of the grounds for such action by SMPK.

7. Submission Requirement

The applicants shall provide documentary evidence to SMPK of their eligibility and their capability and adequacy. In addition, while applying for this EOI, the applications shall include the following information:

8. Language of Application

The language of the Application shall be in English only.

9. Submission of EOI

A) Number of EOIs

An Applicant is eligible to submit only one Application.

B) EOI Submission Date

EOI must be submitted, as per the prescribed date and time mentioned above.

C) Late Submission:

EOI received after the deadline for submission prescribed by SMPK will be rejected.

10. Modifications and Withdrawal of EOI

No modifications/ withdrawal of the EOI shall be allowed once it is received by Syama Prasad Mookerjee Port, Kolkata.

11. Jurisdiction

All disputes arising shall be subject to the jurisdiction of the appropriate court at Kolkata, India and will be governed by the laws of India.
