For late delivery, LD clause would be applicable and it would be imposed on basic value of the rate @½% per week or part thereof of the basic value of the the order subject to a maximum of 10% of the basic value of the order. However, GST at the prevailing rates would be applicable on the LD amount, if any.

15. **SECURITY DEPOSIT**:

S.D. @ 3% of the total basic value will be deposited by DD or in the form of Bank Guarantee, which will remain valid till successful expiry of the Guarantee period of last supply.

16. **GUARANTEE**:
